- In order to run for any of the above mentioned offices you need to submit a petition stating which office you are running for and the length of the term, plus the signatures of 30 registered voters. **We cannot accept petitions that lack the term of office.** If you have questions or would like a blank petition please contact us. **The deadline to submit a petition is 5:00 PM on Monday, January 25, 2016.**
- Also, the Presidential primary election will be in conjunction with the Town Election. At the Presidential primary it is necessary to state which party ballot that you wish to vote. The party ballot that you choose is notated on the checklist. The election officials are required to track this information. At the State primary in August you are given all of the party ballots and vote one party, and we do not track that. Different rules for different elections!

Please remember that both voting districts: District 9-1 and District 9-2 are voting at the Colchester High School Gymnasium for all elections.

Finance Department

Fiscal Year 15 Update: The Town finished the year with a surplus of revenues over expenditures of \$187,791. These funds were reserved by the Selectboard to be used in the FY 17 budget, to reduce the amount necessary to be raised by property taxes. We instituted the local option tax (LOT) on October 1, 2015, We estimated about \$1.2M in receipts annually; therefore we estimate about \$900,000 for this partial fiscal year. We are using about \$600,000 annually to pay for debt service. Local option tax revenues in excess of debt service payments will be placed in a special fund which may only be spent for voter approved capital projects. The voter approval of the local option tax placed restrictions of the use of these funds and has since been incorporated into a change in the Town's Charter documenting the authority and restriction.

We have received the draft audited financials from our auditor with no findings. Audit preparation included a "fixed asset inventory and reconciliation" of 390 assets. The assets include: our half of Lime Kiln Bridge, valued at \$42.8M; a gravel road grader; forensic video software; "jaws of life;" an underwater search camera; a "life detector system;" and mobile radios worth \$1,714.

Fiscal Year 16 Update: Four months or 33.3% through the fiscal year, revenues were higher than expenses by \$277,918, a net positive of about 3%.

- Revenue is 2% higher than what we expect it to be at this point in the year
- Expenses are 1% under budget at 32% spent

Police Department

In the past month Colchester Police Department has responded to 758 calls for service and made contact with 466 vehicle operators during traffic stops. From those encounters we arrested 36 people for 45 crimes ranging from DUI to drug offenses, larceny, resisting arrest, and others. Our motor vehicle stops were greater than usual this month due to special enforcement efforts over the Thanksgiving holiday as part of the national “Click It or Ticket” campaign. We anticipate more traffic details focusing on all aspects of roadway safety during the Christmas and New Year’s holidays. We will be focusing on distracted and impaired driving, use of seat belts and aggressive driving. Please make your holiday plans accordingly – if you have time to think about what to wear to a party, then you have time to think about how you will get home safely.

On behalf of all the women and men of CPD, we wish the community a happy and healthy holiday season! We have numerous exciting initiatives on tap for 2016 and we look forward to our continuing partnership with the community to keep Colchester one of the best places to live in America!
