It's been a difficult couple of weeks for our law enforcement employees as we watched horrific events unfold in Louisiana, Minnesota, and Texas. Chief Morrison had to advise our police officers to be on guard for possible threats. Thankfully, our Colchester Police Department makes it a priority to engage positively with people of all races and religions and has enjoyed tremendous support from the community. Many of you commented about the positive energy around the prayer services in Fort Ethan Allen. Our Police Department assisted with traffic detail for a crowd of more than 800 Muslims who gathered to celebrate Eid and the end of fasting over the month of Ramadan.

During what appears to be a national epidemic of extreme views and polarized communities, it seems especially important for us to participate in all forms of civic engagement to foster empathy for one another. Our Fourth of July parade recently provided one such opportunity to gather together as a community. The business owners and citizens who took time to decorate floats and vehicles contributed to the celebration. Parade Grand Marshals Clinton and Carol Reichard were recognized for many years of volunteer service to various organizations in Colchester. We watched our volunteer firefighters and emergency responders go by in shiny trucks and dress uniforms; these are great examples of citizen engagement through community service.

Imagine what our community would be like if no one volunteered; no one coached kids, put together floats, served on boards, volunteered as firefighters or in rescue. One of the most precious commodities anyone has is time. There is always a need for your donation of time, no matter how limited. It can be as simple as contributing new ideas for the parade and helping to build a float; contributing a few hours at the Triathlon in July; or making a longer term commitment to the Recreation Advisory Board or Planning Commission.

The Colchester Planning and Zoning Department reports the following for the week ending of July 15, 2016:

- The Colchester Development Review Board will meet on July 27th to review the following applications:
 - 1) Conditional use application of Jeffrey Pecor and Richard Pecor for the construction of an accessory structure exceeding 50% of the ground floor of the principle structure located in the R10 District with a boundary line adjustment between the two parcels located at 2808 Middle Road and 2868 Middle Road, Tax Map 15, Parcel 23-1 and Tax Map 15, Parcel 23
 - 2) Preliminary and final plat applications of Spruce Hill Farm, LLC for a five (5) lot subdivision of an 88.15 acre parcel, with each parcel to be developed with a single family residence, located at 1751 East Road, Tax Map 12, Parcel 26

3) Site plan application of Dave and Claudia Pratt for the placement of approximately 8,000 cubic yards of fill to a property located at 568 Main Street, Tax Map 25, Parcel 1.

- The Planning Commission will meet on July 19th at the Town Offices in the Outer Bay conference room to continue its discussion of the Northeast Quadrant as well as to consider possible changes to the Town Plan to reference the new proposed zoning districts for the West Lakeshore Drive area. On July 26th, the Colchester Select Board will hold a public hearing on the proposed zoning for the Malletts Bay Initiative. Highlights of the July 12, 2016 Selectboard Meeting:

- The Selectboard approved a motion to apply for a grant for the VTRANS Mountain View Sidewalk Project on the south side of Water Tower Hill from Route 7 to Water Tower Circle, approximately ½ mile.
- Colchester Code of Ordinances Amendments: The First Reading of amendments to Chapter 1, General Penalty; violations and Chapter 12, Traffic was approved. A public hearing on both will be warned for August 9, 2016.
- A draft Resolution for a Regional Dispatch Implementation Report was presented and approval was given for Colchester's participation in the study.
